# TERMS OF SERVICE FOR SELF GUIDED TOURING

THESE TERMS AND CONDITIONS (THE "TERMS") ARE A LEGAL CONTRACT BETWEEN YOU AND SMARTRENT TECHNOLOGIES, INC. (THE "COMPANY") AND THE PROPERTY OWNER AND THE PROPERTY MANAGER OF THE RESPECTIVE PROPERTY YOU ARE TOURING (THE "PROPERTY MANAGEMENT TEAM"). THE TERMS EXPLAIN HOW YOU ARE PERMITTED TO USE THE WEBSITE ON WHICH THESE TERMS ARE FOUND (THE "SITE") WHICH IS PROVIDED BY THE PROPERTY MANAGEMENT TEAM AND THE COMPANY AND THEIR LICENSORS AND THE SELF GUIDED TOURING SERVICES (THE "SERVICES") WHICH ARE PROVIDED BY THE PROPERTY MANAGEMENT TEAM. THE SERVICES ALLOW YOU TO TOUR THE PROPERTY (THE "PROPERTY") FOR THE PURPOSES OF YOU EVALUATING WHETHER OR NOT YOU WISH TO BECOME A RESIDENT AT SUCH PROPERTY. BY CLICKING THE "I ACCEPT" BUTTON BELOW AND USING THIS SITE, YOU ARE AGREEING TO ALLTHE TERMS; IF YOU DO NOT AGREE WITH ANY OF THESE TERMS, DO NOT ACCESS OR OTHERWISE USE THIS SITE, ANY SERVICES AVAILABLE THROUGH THIS SITE OR ANY INFORMATION CONTAINED ON THIS SITE.

### Changes.

The Company may make changes to the content offered on the Site at any time, and the Property Management Team may make changes to the Services at any time. The Company can change, update, or add or remove provisions of these Terms, at any time by posting the updated Terms on this Site and updating such posted Terms with the latest update date. By using this Site after the Company has updated the Terms, you are agreeing to all the updated Terms; if you do not agree with any of the updated Terms, you must stop using the Site and the Services.

#### General Use.

By using this Site, you represent, acknowledge and agree that you are at least 18 years of age. If you are not at least 18 years old, you may not use the Site at any time or in any manner or submit any information to the Company or the Site.

The Company provides content through the Site and through the Services that is copyrighted and/or trademarked work of the Company or the Company's third-party licensors and suppliers or the Property Management Team (collectively, the "Materials"). The Submissions will be used by the Company in accordance with the Company's privacy policy which is available at https:// smartrent.com/privacy (the "Privacy Policy"). Generally the Submissions will be used to allow you to access the Services, including to provide you with access to the residential unit and take a self-guided tour of the property; it will be used for the Property Manager's internal business purposes, such as ensuring the security of a residential unit before, during, and after your access thereto and contacting you regarding the rental of a residential unit; and will be used by the Company for its internal business purposes including improving the functionality of the Site. The Company reserves the right to delete your Submissions at any time without notice to you. You acknowledge and agree that certain third parties may be used to process your Submissions, and such third parties shall use and process your Submissions in accordance with their own terms and conditions. The Company expressly disclaims any and all liability for any acts or omissions of such third parties, as well as the Property Management Team's acts or omissions, related to their use or processing of your Submissions.

All Submissions that you provide must be accurate, complete and up to date.

## Unauthorized Activities.

When using this Site or the Services, you agree not to:

- Provide any false information or information not belonging to you
- Obscure your identity
- Commit any harmful or tortious act while on the property or using the Services

- Damage any property
- Harm any person

If any of these Terms is found to be inconsistent with applicable law, then such term shall be interpreted to reflect the intentions of the parties, and no other terms will be modified. The Company's or Property Management Team's failure to enforce any of these Terms is not a waiver of such term. These Terms are the entire agreement between you and the Company and the Property Management Team and supersede all prior or contemporaneous negotiations, discussions or agreements between you and the Company and the Property Management Team about this Site and the Services. The proprietary rights, disclaimer of warranties, representations made by you, indemnities, limitations of liability and general provisions shall survive any termination of these Terms.
